- b. You can seek a second opinion from another counselor or terminate at any time.
- c. In a professional relationship (such as ours), sexual intimacy between a therapist and a client is never appropriate. If sexual intimacy occurs, it should be reported to the State Grievance Board.
- d. Generally speaking, information provided by and to a client during counseling sessions with a counselor is legally confidential; and the therapist counselor cannot disclose the information without the client's consent.
- e. There are exceptions to the general rule of legal confidentiality They include:
 - * If records are ordered by a judge in a court hearing or trial.
 - * If there is a violent act or threat of violence to property, self or others.
 - * To Medical personnel in a medical emergency
 - * Child protection laws supersede these confidentiality laws and we are required to report all child abuse and neglect

Exceptions are listed in the Colorado Statues (see section 12-43-218.C.R.S.) If there are other exceptions that are relevant, I will identify them to you as soon as the situations arise in our counseling.
